## **Rules for our Dogwalkers**

Thank you for wanting to walk a dog from APASA. However there are a few rules associated with this which have to be observed and respected.

1. Everyone who wants to walk a dog for the first time has to show an ID card, passport, or driver's license and have it copied.
2. When you come to walk a dog, please first contact the Shift Leader and wait for his/her instructions. Not every dog you want is suitable for walking or for the person.
3. Please wait for a staff member to hand you the dog and immediately take it outside the shelter. (The dogs still in the kennel are stressed, when they see their kennel mate going out).
4. ONLY staff have access to the kennels.
5. It is not permitted to mix dogs from different kennels. Should there be a bigger group who want to walk dogs, then only dogs from the same kennel may be walked.
6. It is NOT permitted to bring your own dog, except as a trial in case of an intended adoption.
7. You can, of course, give the dog a treat, but please ask the staff beforehand as some dogs need special food and could have an allergic reaction.
8. While you walk the dog you have to bring a poo bag and a plastic bottle with water, to be able to rinse off possible contamination with urine.
9. Dogs must always be on a lead and may not be taken to a park or to the beach.

10. Please use your common sense when you walk dogs in the summer. Very often the ground is so hot, the dogs can burn their paws. Therefore, only early in the morning or late in the evening. In the winter/spring avoid areas with a lot of pine trees because of the procession caterpillar. Dogs are also not walked during hard rain.
11. Only one dog per person.
12. The dogwalker must be at least 18 years old.
13. The walk should be at least 30 minutes, except older dogs, who cannot walk too far.
14. PPP dogs may only be walked by suitable people with experience and a muzzle must be carried.
15. The dog has to be back at least 10 minutes before the animal shelter closes.
16. The Walker is obliged to respect the legal regulations and those of the association, and must act with all diligence, exempting APASA from any responsibility derived from their failure to respect the rules.
17. Please wash your hands after the walk.
18. Please wear adequate footwear, no flip-flops etc. Some dogs can pull on their lead.


